





11. Terms and conditions for use

- (1) The Units are used to atomize water and liquids similar to water. When such liquids under pH5 acid or over pH8 alkaline are atomized, the vibrator element may deteriorate or become permanently damaged. TDK will not be responsible for such deterioration or damages. Accordingly, the Units should not be used with liquids having an acidity of less than pH5 or an alkalinity of greater than PH8.
- (2) When there is no water or other liquid in contact with the Units even a short time, the vibrator elements should never be put into operation. If the vibrator elements are used in this manner, they could become permanently damaged. TDK will not be responsible for such damage.
- (3) If the Units capacity for atomization is lowered due to substances contained in water or other liquid such as Ca, Na, Mg or Si adhering to the surface of vibrator element and causing permanent damage, TDK will not be deemed responsible and/or liable.
- (4) If the equipment containing the Units is not used for a long period of time, the water or other liquid should be removed and the part for vibrator element should be cleaned. If proper operating instructions and care are not followed, TDK will not be responsible and/or liable.
- (5) In no event shall TDK be liable for any transmission of bacteria or particles harmful to the human body, or for any containing of substances preventing atomization in the water or liquids to be atomized. TDK is not responsible or liable for the build up of bacteria or the lack of a clean water system.
- (6) In no event shall TDK be liable for deterioration of the vibrator element through use of any drive circuit other than that provided or approved by TDK.


